This has reference to your Technical and Financial proposal submitted on 06.11.2017 for the above-mentioned project.

- Further, CVs of remaining 06 (six) Key Personnel along with self-evaluation in accordance with the evaluation criteria prescribed in the RFP shall be submitted for approval prior to signing of the Contract Agreement. The CVs shall be submitted in the format as prescribed in Form T-10 complying the relevant conditions specified in the Clause 3.2.4 of Letter of Invitation.
- Upon submission of required Performance security and approval of remaining six Key Personnel, you are also required to sign the Contract Agreement as per the Clause-9 of Letter of Invitation of RFP.
